The family support services include a Community Facilitator Program, which is a program where a staff person, using a relationship based approach, establishes patterns of supervision for the individual with a disability to provide support; Saturday programs for social skills and enrichment; the Jay Nolan Camp, which is an inclusive residential camp for children (8 -15) with and without disabilities; and lastly, the Foster Family Program, which is used as an alternative to institutional placement for children with special needs, including those that are medically fragile. The consultation services include support to people with Autism and their families to identify what type of assistance is needed and how to implement it; furthermore, the JNCS Training Institute is an educational gateway to advance professional and individual development.
